



SUBARU FORESTER ISSUES MAY START WITH THE CLUTCH

We have a 2009 Subaru Forester Limited with a stick shift. We had no problems until 171,000 miles. Back in February, it began to have trouble starting. I took it to our trusted garage, and it started fine for them. The battery was replaced, and we finally told them to try a new starter.


The problem is still happening. The repair shop had it for a month, and they continued to have no problem with it. Back home, same starter problem. When trying to start it, we either hear nothing at all, or sometimes a little noise, not like it is trying to do something. When it does tart, it starts immediately.

Help! - Connie Hm. They had it for a month and

couldn't figure it out, and you want me to diagnose it through the newspaper? Have you tried Hints from Heloise? It sounds electrical to me, Connie.

Based on your description, I assume hat, when it doesn't start, there's no current getting to your starter. The first thing I'd check would be the clutch interlock. On this car, you have to depress the clutch in order to start the car. That keeps you from driving through your garage door before you

There's a little switch connected

to the clutch pedal mechanism that prevents electricity from going to the starter unless the clutch is fully depressed. That switch could be faulty Or it could just be out of adjustment. Perhaps the big, hairy gorillas who work at the garage are stomping on the clutch so hard that they always engage the switch, but when you're at home, you don't push quite so hard, because you're not an animal.

You might also check to make sure the floor mat isn't bunched up behind the pedals. We've seen that interfere with the clutch interlock, too.

you're holding the key to the start position, try really mashing down the clutch pedal, and see if you can break through those shag carpet disco floor mats you bought in the '70s. Maybe buy a pair of size 12, steel toed hiking boots If that doesn't help, I would guess

that there's another connection that's failing intermittently. So when it won't start, while you hold the key to the start position, have someone else jiggle all of the relevant wires under the hood, one connection at a time. Start at the battery and check both cables. Then try the cable at the starter

that comes from the battery. Then the ground connection from the negative terminal. If you can get the car to start while jiggling a wire or moving a connector, you've found your problem.

Finally, I know they replaced the starter, but if they put in a rebuilt rather than a new starter, it's possible you got another bad starter. But not very likely

I think the clutch interlock is the most likely problem, and that's certainly where I'd start. Good luck, Connie.





FORD ESCAPE SHAKES AT IDLE

My husband and I are both nurses. o we are trained to diagnose things. My husband is not only a great nurse but a fine backyard mechanic as well. But we have a problem with our 2015 Ford Escape that has us stumped.

When I stop at a red light, my car shakes violently, and the RPM drops below a thousand. When I put it in neutral or park, the shaking stops.

We took it to our mechanic, who hooked up a computer that showed no codes, no idiot lights, and no warning light on the dash. They ruled out a bad motor mount and brake rotors being warped, and they cleaned the idle air-control valve.

They are stumped, too. Please help with this problem. If anybody can, you can. – Marsha (for Warsha and Robert)

I'd give you my diagnosis, Marsha, but I need to see your proof of insurance coverage first. Sorry, little hospital joke

It could be any number of things, Marsha. But I suspect you have a vacuum leak. The engine naturally creates acuum every time a piston descends and sucks fuel and air into a cylinder. That "free" vacuum power is then used by other systems in the car. For example, it's used by the ventilation system to ontrol the flaps inside your ducts, and

by the exhaust gas recirculation system to open and close the EGR valve.

If you have a vacuum leak, that means unwanted air is leaking into the cylinders. Because the mixture of gasoline and air in the cylinders has to be just right, a vacuum leak throws off that delicate balance by letting in too much air, and that makes the engine run

There are various ways to find a vacuum leak. If it's big enough, you can sometimes hear it hissing. If not, we sometimes spray combustible fuel cleaner where we think air might be leaking in. If there's a vacuum leak


nearby, that fuel cleaner will get sucked into the cylinders, and we'll hear the engine rev up. Or we pinch off individual vacuum hoses, one at a time, to see if closing one off makes the engine run

There are other tricks, too. But if your mechanic is as good as you say he is, he'll know how to search for a vacuum leak. I will give you one hint for your mechanic: One often-overlooked source of a vacuum leak is the power brake booster

The power brake booster uses vacuum from the engine to multiply the force your foot puts on the brake pedal. It's the "power" in power brakes. But if there's a hole in the booster's diaphragm that'll create a vacuum leak, but only when you're stepping on the brake -- like when you're stopped at a light. If the leak is a small one, when you put the car in park or neutral, you reduce the load on the engine enough to stop the shaking.

So ask your mechanic to set out on an expedition for a vacuum leak, Marsha. Hopefully he'll find it, and your Escape can escape the shakes.





NISSAN XTERRA'S MYSTERIOUS LEAK COULD HAVE YOU HOWLING


I have a 2004 Nissan XTerra with a standard transmission. There is a pretty substantial leak that is dark in color. It looks like oil, but my oil level isn't

The leak is under the engine on the passenger side. Since the oil level isn't dropping, what could it be? My power steering level is fine. Thanks. – Jeff

If it's really dark, it could be a 2016 Preston Vineyards Petite Syrah, Jeff. But more likely, the leak is coming from your front

Differentials allow the left and right wheels to rotate at different speeds, which they have to do when you're turning, or you'll drag your outside wheel all the way through the turn. You have two differentials on this XTerra, because it has four-wheel drive; one on the front axle and one in the rear. And guess where the front differential sits? Under the engine, just to the passenger side of the oil pan. Bingo!

Unfortunately, it's hard to check the oil level in the differential,

because it doesn't have a dipstick. We check it by removing the plug on the outside of the housing, sticking a finger in there (the original dipstick!) and seeing if our finger comes out with oil on it. My guess is yours won't, Jeff. So you'll save a little money on soap, and you can put that toward your new


Actually, you might be OK. It depends on how low the oil level has gotten and how long you've been driving it this way. If you already hear a howling

sound when you drive – if you keep looking in the rearview mirror, wondering why the state police are after you -- then the differential is shot, and you'll have to replace it. But if it's not making noise yet, you can have your mechanic find the leak and fix it. It's most likely leaking from the pinion seal, which is right next to the oil pan. Although it could be one of the axle seals, too. Replacing the seals is actually a relatively easy job. It doesn't require removing the differential, and it'll probably cost you in the neighborhood of \$250.

On the other hand, if it starts howling, you'll need to find yourself a good, used differential, and you'll be looking at three to five times that price. So stop reading and go get it taken care of now, Jeff.


